A CBTF Record of Violation must be filled out and sent the CBTF Judges Representative. b) If a CBTF Judge judges an event(s) at a CBTF Sanctioned Competition (exception: Type C Competitions) and is not certified to do so, he/she shall be fined \$100.00. If this action is repeated, he/she shall be suspended from judging at CBTF competitions. c) All competitions sanctioned by the CBTF are to run in accordance with the standards as set forth within CBTF Policies and Regulations.
