- The entry deadline is **February 5, 2024 11:59 pm CST (Regina time)**. All entries are timestamped by the online entry system. NO LATE ENTRIES WILL BE ACCEPTED.
- **Health Certificate for all WC CBTF Qualifier athletes:** The official CBTF Health Certificate is available on the CBTF website: <https://cbtf.ca/article/2024-cbtf-health-certificate> [1]. It must be completed and signed by a physician. The form must be submitted to [office@cbtf \[dot\] ca](mailto:office@cbtf.ca) by February 16, 2024. If the medical certificate is not provided, the athlete may not be eligible to compete at the Qualifier. Electronic copies are acceptable - they must be a clear, scanned copy, not a smartphone picture.
- Payment must be made by Interac eTransfer to [treasurer@cbtf \[dot\] ca](mailto:treasurer@cbtf.ca). The payment deadline is **February 5, 2024 11:59 pm CST (Regina time)**. LATE PAYMENTS ARE SUBJECT TO PENALTY.
