### **General Information**

1. Judges decisions are final. Tabulated results are considered official 48 hours after announcement or posting.
2. FLASHCARD JUDGING will be used for competitive events, except for Level C & BN Primary & Juvenile divisions (graded system will be in effect). All results will be posted. Posted awards and scoresheets may be picked up from the awards table.
3. Entries to be submitted online with the provided link.

6. AWARDS:

7. ORDER OF EVENTS: Pre-Competitive Events: Basic March I & II, Forward Motion I & II, Medley I & II, Solo Dance I & II, Solo I & II, 2-Baton I & II, Group Events, unofficial "Twirling With My Valentine" (parent/athlete duo event), 3-Baton, 2-Baton, Solo, Duet, Medley, Solo Dance, X-Strut, Freestyle, Pairs. During lunch, there will be an unofficial "Toss Turn". All individual competitive events will be offered twice. The competition director reserves the right to change the order of events to facilitate the flow of the day.
8. All athletes and groups must declare any medical support/brace worn for the prevention of injury as deemed necessary by a physician. Copy of medical certificate must accompany athlete's entry.
9. CBTF RISK MANAGEMENT POLICY: i) The competition director or designate will have the authority to immediately stop the competition whenever a risk factor related to safety becomes evident, ii) If this situation occurs during individual competition, the competition on the lane where the

situation occurs will be stopped on the lane only, iii) If an athlete has to leave the competition to seek outside medical assistance because of a situation that has occurred during a competition, they will require a medical certificate in order to continue competing.

10. PRACTICE AREA: During the competition, there will be a small practice area in the gym for a designated number of athletes.
11. A \$10.00 gym fee (per athlete) or \$15.00 gym fee (for families with 2 or more athletes) must be included with entry.
12. The competition director has the authority to make any last-minute changes.
13. Competitive (individual, duet and group) athletes' minimum age is 6 years.
14. All athletes and coaches must be registered members of the CBTF for the 2025-26 season.
15. Errors or omissions will be corrected via email from the entry processor.
16. Refunds are given for an injury-related withdrawal if a medical certificate is provided.
17. First-aid will be available on-site.
