1. Treasurer's Report (Apr 1 2010 – Mar 31 2011)

Question (SK): Why is no audit is performed on the CBTF books?

Answer (Treasurer): CBTF has a Finance Committee in place and therefore an audit is not required. One could still be done – Janice would recommend it. Michelle indicated that, in the past, cost has been the primary reason against conducting an audit.

Sanction Officer's Report

- Gail: Events should not be posted on the CBTF website until Sanction Numbers have been assigned
- Elan: Also feels nothing should be posted on the website until a Sanction Number has been assigned.
- Jeff: Feels the events on the CBTF website should be a complete calendar and it is more useful as a planning tool the sooner events can be posted. Events that have not yet received a Sanction Number are listed as 'Pending'.
- Gail: Should we change the process so that Event Directors are not required to submit a brochure before obtaining a sanction? Any change in process will require a review and Board approval.

Coaches' Rep Report

- After a great deal of effort, the CBTF Coaches Database has finally be caught up and is now up to date with information from the past 10 years now in place.
- Beginning September 2011, once Coaching Courses begin, Course Conductors will be responsible for issuing certificates and updating the database after a course is completed.
- We have a significant number of members that have taken Coaching Courses but do not hold a
 Technical Membership. These members should be encouraged to take out a Technical Membership

 to be a certified CBTF coach they need to both pass the courses and also hold a Technical
 membership.
- Reminder: CBTF regulations require L1 certification or greater in order to supervise in a competition's practice gym. And L2 certification or greater in order to enter athletes in competition.

Data Entry Coordinator Report

- The CBTF Membership program requires Birthdate for all athlete membership types A, B, BR and G
- Group Declarations: These forms need to be submitted before any work can be done to prepare the Canadians Set System or do the calculations for the Group Challenge Cup. This year, many Group Declarations were not submitted until the week of Canadians – this doesn't leave enough time for the work.
- Jeff: A reminder to all provinces and Competition Directors that Competition Results are required to be submitted to the Data Entry Coordinator within 7 days of the competition's end. The Executive has discretion to levy financial penalties if Competition Directors fail to do so.

CBTF Constitution and By-Law Changes 4.

2011 AGM MOTION #7 PASSED

I move to approve the WBTF mandated changes to the Charter by adding to Article A, sections 3.2 and 3.3 which shall read as follows:

- 3.2 The CBTF is a member of the WBTF. Members of the WBTF agree to and accept the principles of the International Olympic Committee and World Anti-Doping Code and its International Standards as well as the World DanceSport Federation (hereinafter referred to as "WDSF") Statutes and WDSF Anti-Doping Code and related procedures as a condition of membership, requiring all athletes, athlete support personnel and other officials within their jurisdiction to recognize and be bound by these rules and procedures, and to abide by the decisions and instructions of the WDSF Anti-Doping officials.
- 3.3 Members of the WBTF accept and recognize the authority of the WDSF Anti-Doping Commission and the WDSF Anti-Doping Director. The WDSF Anti-Doping Commission and the WDSF Anti-Doping Director are appointed by the WDSF Presidium. It is a condition of membership in WBTF that the WDSF Anti-Doping Code and all related procedures are accepted by all WBTF members and that all athletes, athlete support personnel and all other officials in WBTF are bound by these rules and procedures.

2. Article D, section 3.3

Indicates forms of individual members, if we include an Instructor category, then this needs to be added:

D) coaches/instructors

3. Article D, section 4.5 lists the provinces and territories

We need to add:

Nunavut Territories

4. (Article G 1.2 prohibits power of attorney or proxy voting)

5. Article G, section 4 addressed telephone conference call meetings

It requires that the President contact each person by telephone to advise them of the meeting. It is proposed that this mechanism be changed from: "verbally via telephone call" to "directly by electronic means with confirmation receipt".

11.1 A) In the event the Provincial Chairperson/President cannot represent his or her Provincial Association at a meeting of the Board of Directors at the Annual General Meeting of the Federation, or at any other meeting as required, then a Board Member of that Provincial Association, appointed by Provincial Board motion, a certified copy of which shall be provided to CBTF in advance of any such meeting, shall be entitled to represent that Provincial Association at that meeting. Such representative shall, notwithstanding Article G 1.2, have the right to vote at such meeting.
