A PILOT PROJECT FOR THE 2025-2026 SEASON

The intent of the Advancement Appeal process is to give coaches a mechanism to challenge advancement scores that may not reflect the athlete's performance. The process is designed to be confidential to protect the competitor, coach, and judge using a fair and independent review mechanism that ensures the timely distribution of a decision.

INITIATING AN APPEAL

If a coach deems than an athlete has received an advancement score in a mandatory in-season advancement discipline (a mandatory in-season advancement discipline applies to Solo, 2-Baton, 3-Baton, Solo Dance Twirl, Medley, Duet, Twirl Team, Dance Twirl Team, and Pom Pom Team, or any other similar CBTF event where an advancement score at one competition will cause a change in division at the following competition within the same season) at an open competition in which they would like to challenge, the coach must email the CBTF Judges Rep and cc the CBTF Technical Chair with the following:

- Attach:
 - Video of the performance in question
 - The video must be from that performance at the competition at any angle, preferably from the front
 - Scoresheet from the performance in question
- Include in the email:
 - o Name of Athlete
 - o Name of the Judge
 - Name of the Competition
 - o Discipline
 - o Division
 - Age Category
 - o Score Received

Fee: \$50 paid to CBTF, with each judge being compensated \$10 for reviewing the video and a \$20 fee to CBTF for the processing.

Timeline for Submission: All of the above must be submitted within 48-hours of the end of the competition, including etransfer of fees to the CBTF Treasurer. The CBTF Judges Rep will notify the CBTF Treasurer to let them know when the etransfer has been received.

PROCESS

The intent of this process is to keep the appeal as confidential as possible for the sake of the athlete, coach, and judge.

The CBTF Judges Rep will only distribute the video—devoid of name or other identifiers, as is possible—to a panel of three judges to score the video. Judges will be directed to watch the video one time and only answer "did this performance meet or exceed the minimum score of the [NEXT LEVEL?]"

Judge Selection: the three deciding judges will be pulled from a pool of all eligible CBTF judges with a minimum of two years experience. The three judges must be from at least two different provinces. A judge cannot have been the judge who initially scored the routine. Networking lists will also be considered when selecting judges for the panel.

The pool of judges will meet with the Judges Rep at the start of the competition season to discuss the procedures for reviewing an appeal, as well as rules for consistent treatment.

Turn Around Time: the appeal committee will have a reached a decision within 4 days of the receipt of the supporting documents and fees.

OUTCOMES

Successful Appeal: If two or more of the three judges respond that the athlete does not meet the minimum score of the next level, the advancement score will be overturned. Overturning the score does not change the placement from the competition. The score, however, will be removed from the record. This implies that the overturned score cannot be used as a minimum score for entry into a qualifier or other similar purpose.

Denied Appeal: If two or more of the three judges respond that the athlete meets the minimum score of the next level, the advancement score will remain.

The appeal decision is final.

An appeal can be submitted only once per season for an athlete for a particular discipline and division.

Distribution of Decision: The CBTF Judges Rep will report the decision of the appeal to:

- The coach who submitted the appeal and CC CBTF Technical Chair.
 - o It is the coach's responsibility to forward the decision letter to any upcoming competition director(s) to ensure that the athlete remains in their current level.
 - The appeal letter will state the athlete's name, discipline, division, and age category and the appeal decision. The name of the judge shall not be included in the letter.

SAMPLE APPEAL DECISION LETTER

Dear [Coaches Name]
